31 Heijnis opens the meeting at 13:09.

37 We do not have quorum so the minutes cannot be confirmed. The council discusses the OV minutes
38 from the 2nd of November. Verhave takes up the comments from the council. The PV minutes will be
39 confirmed during the next PV.

44 As there is no quorum the council discusses how to move forward with the PV. Heijnis investigates the
45 possibility of someone temporarily joining online so the voting can take place.

48 *Chair, vice-Chair, workgroups, and CSR-delegate share updates.*

50 Benjamins updates regarding the quality funds. Benjamins explains that for our FSR we are better involved
51 compared to other faculties. He will ask a question about this on the upcoming OV. Furthermore, he has
52 been working on the subject of institutional tuition fee. As something has changed in the policy that the CSR
53 does not agree on, the advice has been changed from positive to negative. The policy was regarding inflation
54 being taken into account for tuition, but the CSR does not agree on this point. The CSR is also working on
55 the UvA house rules.

57 Heijnis updates about Tip's workgroup. They worked on the letter regarding Israeli universities letter. He
58 also replied to the council assistant applications. He also updated the *studentenraad* website with the
59 confirmed minutes and our group pictures.

61 **7. Deciding: Israeli universities letter (20 min) (attachment: 1)**

62 *The FSR decides whether to send the letter regarding cooperation with Israeli universities.*
63

64 Heijnis introduces the letter he and Tip worked on. Van Eck updates the council on the update from the
65 international court. He suggests adding the court decision in the letter. Van Eck refers to several cases
66 where UvA students are threatened by a speech by pro-Israeli students, which led to a socially unsafe
67 situation. At the University of Antwerp, their law faculty has chosen to break ties with Israeli universities
68 and decided to stop working on research projects involving Israeli universities. Heijnis is very positive
69 regarding the third point Van Eck suggested. Heijnis is planning to discuss this during TTO, which is an
70 informal situation. Van Eck explains that the point regarding social safety would be great to discuss during
71 the OV. Van Eck wants to emphasize the international court update and the point of the University of
72 Antwerp. Heijnis suggests adding these points, but maybe leaving the point of social safety as a point for
73 later discussion.
