1. Opening

Heijnis opens the meeting at 14:20.

31 2. **Mail and action points** (15 min)

The FSR discusses the email list. Boll would like to join the meeting in June about the food on campus. On the 4^{th} of June, there is the final diversity office sounding board. They will be mainly discussing the decolonial dialogues – Tip and Benjamins would like to join. The email about the poll about the university quarter Selin and Ivar will share it on the social media [ACTIONPOINT]. Heijnis will join the OERevaluatio meeting on the 20^{th} of June. Tip and Hejinis would like to join the meeting about the international strategy 25^{th} of June 10:00. We will discuss the VOS funding request next week [ACTIONPOINT]. Verhave will respond to ALPHA [ACTIONPOINT].

3. **Confirmation minutes** (5 min)

The minutes are not ready so will be discussed next week.

4. **Confirmation agenda** (3 min)

Benjamins proposes to add a point of discussion regarding the Dutch tracks. The agenda is confirmed.

5. Announcements

There are no announcements and no mandates.

6. Updates (10 min)

Chair, vice-Chair, workgroups, and CSR-delegate share updates.

Kracht updates that the social media this week has been doing very well, we had a lot of engagement so they hope we can keep it up during the elections. Benjamins updates that the CSR has handed in a vote of no confidence to the CvB. The motion of no confidence has been passed. This vote of no confidence is also related to institutional fees and how the tuition fee has been raised throughout the years, going against the intended policy. Furthermore, we received election posters from the CSR.

12. <u>Discussing:</u> unsolicited advice institutional restraint (35 min) (attachment: 1)

The FSR discusses the unsolicited advice regarding institutional restraint

Hejinis introduces the letter. Heijnis asks the council if they have any questions or comments. It is a continuation of the discussion held earlier at the OV. Kracht likes the letter. He says the letter refers nicely to the wording of the statements made by the board. Kracht asks about the integration of institutional restraint and how we see it to be implemented. Heijnis responds by explaining the criteria for a statement to be made by the board. Kracht identifies two challenges in this advice, the university having to admit being a political organisation and then secondly how they would exert this identification. Heijnis responds that the dean has already agreed to the university being political, as they said taking no position is also a political position. Kracht likes how the letter uses *medezeggenschap* as a political function and takes it further than the university itself. Verhave suggests tying the letter to the statement made by the CvB earlier this week. Heijnis responds that this is exactly why he wants there to be a policy on this issue. The council discusses when to send the letter.

Kracht suggests sending it as quickly as possible. Benjamins proposes the opposite and to send the letter next week. Tip and Boll agree with Kracht. Benjamins prefers the option of sending it later because it will come

across more as a thoughtful response and something to continue the conversation. Heijnis says that there could be very negative or very positive consequences by sending it as soon as possible

It could lead to a discussion, or they could shut it down because it adds to the discourse. Kracht responds that sending it now actually gives the council the power to question why they shut it down. Heijnis proposes to discuss the letter more and reflect on it overnight and hold a Whatsapp vote for sending. The council agrees.

13. Discussing: consent request Dutch tracks

The council discusses the letter. The OCs are positive. There are questions about the segregation between Dutch and international students, whether the number of Dutch students will increase, and if the current number of Dutch students in the programs is enough for a complete track. Currently, the council is sceptical about the potential execution of the Dutch tracks. [ACTIONPOINT] We should discuss this with the OR.

14. Discussing: **UvA protests** (20 min) (attachment: -)

The FSR discusses the protests that are taking place at UvA

Heijnis updates about the protest and the response from the CvB. The CvB published a list of research ties with Israeli institutions, including the exchange programs. Heijnis updates about the nature of the protests and the police presence. The communication between UvA and the police is also a question. The police threw away food from the encampment at roeterseiland without reason, the police mentioned this was requested by the UvA. The protests the next day turned into a march, which turned into an encampment at the Academische club because the door was open. Part of the staff asked for a strike. During the negotiations last night, it was decided to not file charges. There will be more negotiations after our PV time. We are unsure who is in charge, but there are people taking the lead.

15. PR of the week (5 min)

PR has been discussed.

16. Final points and closing

The council forgot to discuss elections. The PV is closed at 16:00.
