- 49 Heijnis is keeping in touch with the OR and agreed that the new council should meet the OR at the
50 beginning of the year.

- 55 Heijnis informs that he was under the impression that we would start planning the *inwerkweekend* after
56 the new council members are known. Because the CSR-delegate needs to be decided earlier this might have to
57 be done separately earlier. Van Kasteel will spearhead the *inwerkweekend* planning. We will pick a PV date in
58 June for the new council members to vote on their CSR delegate. Heijnis proposes the 5th of June to invite the
59 new council members and let them vote on a CSR delegate. Van Kasteel proposes to invite them on the 5th and
60 there the CSR delegate will be explained [ACTIONPOINT]. Then on the 12th, they can send in their applications
61 and vote on the position.

- 65 Tip says the meeting on Tuesday went quite well, there were points the OR also supported. They were quite
66 wishy-washy – they were discussing the police presence. The fDB responded that the driehoek decides on this,
67 were some OR members responded that they are also responsible for this. Senchi adds that the fDB did not talk
68 a lot during this meeting. Senchi says the FSR and the OR agreed on a lot of points even on points that they did
69 not expect to agree on. Senchi says it feels like the fDB does not have a plan, they are just following whatever
70 the CvB is doing at this point. The FSR and the OR also agreed that the dialogues that they are planning is not
71 enough. Senchi is also questioning the presence of the unknown figure at the meeting. The university is also
72 planning to rework the ethics guidelines. Heijnis also wants the FSR to take an active role in this. Heijnis also

73 asks the point of view of the other council members. Tip adds that he saw their earlier discussion as to how the
74 AP could function as a party in the grand scheme instead of the functioning of the FSR. The council agrees that
75 the FSR should have an active seat in the discussion regarding the ethics guidelines and strive to have the
76 discussion include the protesters and other students.
