- 30 **1. Opening**
31 The PV opens at 15:06. The new FSR members are attending the PV as guests, and a round of
32 introductions is done. The positions in the FSR are explained to the guests. General workings of the FSR
33 were explained to the guests. Special attention is paid to the position of CSR delegate as the new FSR
34 members will have to put themselves forward for upcoming year.
- 35 **2. Mail and action points (15 min)**
36 Rembrandt, Van Kasteel, and Heijnis all would like to attend the round-the-table discussion regarding
37 ethical guidelines. Verhave will check if it's possible to attend the meeting with more FSR members.
- 38 **3. Confirmation minutes (5 min)**
39 The minutes of the 22nd of May are confirmed.
- 40 **4. Confirmation agenda (3 min)**
41 The AS vacancy will be discussed after the PV. The agenda is confirmed.

43 Benjamins announces that the co-funded event of Amsterdam United will take place at 7:00 in Lab 111.

47 Heijnis was at the discussion about mandatory attendance. They want to include mandatory attendance to
48 put a stop to so many AVV exercises and assignments. The main issue is the vague definition of practical
49 courses. Heijnis said that the vague definitions of mandatory attendance. Heijnis said that it has to be
50 necessary to achieve the learning goals it can be included. Verhave asked about the disallowing of AVV's in
51 practical education, Heijnis said this was not discussed. Heijnis also updates about the chair meeting.

53 Heijnis explains FNWI will be inviting students and staff to *burgerraden* hosted by a third party and there
54 they will be discussing how to move forward and ethical guidelines. The difference is that they invite and
55 include students more proactively. Heijnis prefers this to the FGw approach.

57 Tip updates about the sounding board meeting. The FDO is working on a plan for the DO and how they want
58 to make a permanent sounding board that includes compensation.

60 Noah updates that the kaderbrief is happening, which is the precursor for the UvA budget. Furthermore the
61 CSR is going into mediation with the CvB.
62
63 Heijnis updates that there will be a meeting with all chairs and the rector. They decided it is best to go
64 anyways and state again that we do not have confidence in the current executive board of the UvA.

66 Verhave updates about the OV and that she cannot be present for the PV on the 19th of June.

70 *The FSR discusses the consent request regarding Dutch tracks.*

72 Hidde and Noah update everyone on the Dutch track consent request. The universities are trying to pre-
73 empt the law and they're trying to make their own policy before the law even comes out. The advices of the
74 PC's are in the line of this thinking on the Dutch tracks. One of the major reservations is that the faculty is
75 not investing anything in the creation of the new tracks. The Daily Board is also seeing opportunities in this,
76 which are not necessarily opportunities the programs are seeing. Media and Information is also struggling
77 to see how a Dutch track will add to their program. Furthermore, Heijnis offeres to write the advice tonight
78 and we will vote on it through WhatsApp.
