#### 1. Opening

Stefanova opens the meeting at 14:08.

## 2. Mail, agenda, and action list (10 min)

Mohammad proposes to discuss the CoBo date and specifications. The council agrees on certain 'bras' rules: keep brassen to a minimum, do not bras anything from the location and try to consider non-alcoholic gifts as well.

Bruseghini updates on the new deadline for the budget advice.

The minutes are confirmed under the condition that the vote per mail regarding the no confidence is included in the decision list.

Heijnis updates on the communication with G1000. A letter has been sent to the fDB to plan in a meeting with G1000.

Bruseghini gives updates on the CSR. The CSR voted to lift the no confidence in the university's board, so the trust is restored. The reasoning and conditions are explained.

The FSR discusses the Budget.

Bruseghini gives an update on the budget. It has been drafted. Bruseghini offers explanations about the specific cuts that are planned to take place, which departments will be mainly affected by these budget cuts but also shares on budgets that will remain the same. Heijnis informs the council on the budget plans that were set up last year. As a follow up to last year's situation, Stefanova will contact ALPHA and ask about their current board grant situation [ACTIONPOINT].

Eng follows up on the updates given by Bruseghini. Eng elaborates on the factors he wants to dig in and offers an explanation.

## 10. Deciding - OER Division (15 minutes) (attachment: 17)

The FSR decides on the OER division and discusses mandatory attendance.

Heijnis proposes to make a division on assessing the OER files including the proposals we have received. A division is made of two groups: the first group looks at the OER and will set up new advice points and changes (focus on examinations, see if there are changes you would like to make to the rules) and the second group checks for the changes they are proposing (think of what implications that will have on students and add comments to the document).

# 11. Discussing and Deciding - AP Unsolicited advice (10 minutes) (attachment: 1)

The FSR discusses the AP unsolicited advice.

Heijnis elaborates on the unsolicited advice set up by the Activist Party. The advice calls for the inclusion of the term '(plausible) genocide' in the university's communication regarding Palestine. Thantry suggests that the letter should also include that the university has to start recognizing and acknowledging the Palestinian people as the victims, since this is currently completely being disregarded by not including the words 'Palestine' and 'Palestinians'. Mohammad follows up that the aggressor should also be specified in the university's communication. Tip adds that the university's communication regarding the situation in Ukraine should also be included in the letter to showcase the contrast in communication by the university when discussing the two situations. A vote regarding the letter and amendments takes place. The council votes to send in the unsolicited advice to the fDB.
