17. Opening

Heijnis opens the meeting at 15.12.

18. Mail, agenda, and action list (10 min)

Mohammad shares that there are no updates on the mail. Heijnis goes through the agenda. Mohammad elaborates that attendance of the bake sale preparations is considered attendance of the workgroup, which also applies to attendance of the bake sale on Thursday. Kestoros will share the study session post with the Humanities study associations [ACTIONPOINT].

The council goes through the action list.

19. Announcements (2 min)

Thantry has to leave the meeting at 16.30. Bruseghini might have to depart earlier as well due to illness. Eng queries when the staff strike will be discussed during today's agenda. Heijnis decides to add it as an agenda point. Eng shares that he will invite a couple of guests to next week's plenary.

20. Confirmation agenda (3 min)

The agenda is confirmed.

21. Confirmation minutes (10 min)

The minutes are confirmed.

22. Updates (10 min)

The chair, vicechair, workgroups, and CSR delegate share updates.

Mohammad updates on the new OV date that will take place on the **18**th **of March** from **13.30-15.00** in BG3. Heijnis will inform the technical chair Noah Benjamins about the new date [ACTIONPOINT].

Bruseghini shares the CSR updates. The FSR's will receive a new legal advice within two weeks. The CSR voted in favor of supporting the staff strike on the 17th of March. The CSR will request an extension for the house rules and ethical framework for collaborations with third parties. Bruseghini shares the request to communicate any comments regarding the kwaliteitsmiddelen/quality agreements funds.

The FSR discusses a point brought by Ioanna Kestoros.

Kestoros received an update on Monday regarding our request for permission to hold the bake sale. Because of conflicts regarding catering, our request was denied. Heijnis shares that he was in contact with the canteen staff who said they are ok with it. Heijnis will talk with security on Thursday morning.

Thantry shares that our request to hold the Stukafast program in the council's office has been approved.

8. Discussing - Staff Strike (10 minutes) (attachments: 0)

The FSR discusses the upcoming UvA staff strike on the 17th of March.

A new nationwide staff strike has been planned for the $17^{\rm th}$ of March. The CSR has voted in favor of the strike. Eng requests a vote to take place on the FSR level as well. The council will await the strike plan prior to holding the vote.

The FSR discusses the piece we got on the FSR's powers within the UvA and following steps.

Heijnis queries whether the CSR has discussed the legal article internally. Bruseghini responds that the discussion has not taken place yet. Heijnis shares a summary of the legal document. Kulazhenkova raises the point whether we have insight into which directives were implemented under this rule. Mohammad wonders whether the decisions taken under this rule can be undone retroactively. Mohammad proposes to contact the legal department of ASVA. Heijnis proposes to attach this topic to the Administration model and culture (democratisation) file prior to discussing it with the fDB. Mohammad will contact Van de Visse requesting his and ASVA's participation [ACTIONPOINT].
