1. Opening

Stefanova opens the meeting at 15.10.

2. Mail, agenda, and action list (10 min)

The council holds an introduction round for the attending guests.

Mohammad shares the response of the exam committee. Kestoros, Kulazhenkova, and Tip will be contacted regarding their availability [ACTIONPOINT]. Stefanova updates on the survey; it is finalized, and she will share it with Kestoros [ACTIONPOINT].

Eng updates on his invitation to contribute to the quality of UvA's education. He proposes to discuss during one of the workgroups what points the council wants to bring forward given the fact we have insight into what opinions students hold regarding their education.

Eng updates the council on the budget approvement request. Heijnis shares that he was in contact with the previous treasurer about this topic. Eng will proceed by requesting what the faculty's expectations are, sharing the pending amount of last year and await a response to this.

3. Announcements (2 min)

Stefanova will have to depart the meeting at 17.00 sharp. Thantry announces that she will not be able to attend next week's plenary and the upcoming workgroups.

4. Confirmation agenda (3 min)

The agenda is confirmed.

5. Confirmation minutes (15 min)

Heijnis elaborates on the filled omissions in the document of 18-02. The minutes of 18-02 are confirmed.

The minutes of 25-02 are confirmed.

6. Updates (10 min)

The chair, vicechair, workgroups, and CSR delegate share updates.

Heijnis updates on the TTO of 28-02. Heijnis will be the FSR delegate for the faculty's consultative group (*klankbordgroep*) focusing on the Humanities' future in light of the current budget plans. Heijnis will furthermore also partake on behalf of the FSR FGw in the panel on the ethical framework for collaborations with third parties.

Artemyeva updates on the Housing meeting of February 11. Mohammad will ask whether Zep will be able to partake in the Housing meeting upcoming Thursday March 6th.

Eng updates on his workgroup that focused on the upcoming staff strike. Thantry updates on Kestoros' workgroup (led by Tip) which focused on the subsidy policy.

7. Discussing - Meeting pieces (10 minutes) (attachment:1)

The FSR discusses the proposed template on Meeting pieces by Heijnis.

Heijnis elaborates on the agenda point. During the evaluation weekend, the council reached the consensus to make use of meeting pieces for expansive agenda points as a means to facilitate a more efficient discussion. The meeting piece will focus on the motive, objective and main question of the agenda point. Heijnis queries whether the meeting piece should be used for every agenda point or merely for the expansive points. Eng responds that since it will increase the workload, it should only be used for expansive points. Heijnis adds to this that it should also be used for agenda points that require a vote. In case of usage of meeting pieces, the council decided to set a deadline for Friday mornings.

8. Discussing and deciding - Possible collaborations (15 minutes) (attachment:0)

The FSR discusses and decides on collaborating with an organization suggested by Heijnis.

Heijnis mentions that, as shared before, BDS Netherlands requested us to become part of their apartheid free zones coalition. They have a manifesto with numerous BDS demands, which are of similar nature to the pledges we adopted. Heijnis asks whether we want to partake in this campaign? Partaking in the campaign would entail further expanding the apartheid free zone in university by approaching other councils, student parties and organizations/associations. In case we proceed further, we should inform them that as an elected council, future composition and thus the council's stance is always subject to change. The council holds a vote on whether they want to proceed further.

Eng raises the question how to proceed further with the guess correction formula point. Heijnis states that this formula exists and is applied in other faculties as well. He suggests to look whether the OER mentions usage of the formula. Eng will contact Bruseghini whether this is a point picked up the CSR, if not, the council will proceed by writing an unsolicited advice. In case the CSR is already working on this, the council will approach the CSR with their points of concern [ACTIONPOINT].

Regarding the language policy on exams, Eng shares that the faculty will not make changes as it states she is already compliant with faculty policy.

Regarding the use of dictionaries during exams, the council agrees that it should be policy, and if this is already the case, it should improve its communication on the policy. Eng's workgroup will look into whether the OER covers the use of dictionaries during exams.

Eng shares the response from ASVA about our request for free Dutch language classes for Humanities students.

Molin incorporated the feedback received over the past weeks. Stefanova shares Bruseghini's suggestion to include the steps taken at other Dutch universities to accommodate neurodiverse students. The council votes on the advice.
