16. Opening

Stefanova opens the meeting at 15.25.

17. Mail, agenda, and action list (10 min)

Molin looked into the fire policy during Eng's workgroup. Stefanova will assist Eng with the annual budget approval. Kestoros updates on the survey. Artemyeva will post the promotion material this week [ACTIONPOINT]. The evaluation meetings are currently being planned by Artemyeva and Bruseghini.

18. Announcements (2 min)

Eng, Stefanova and Thantry will have to leave earlier.

19. Confirmation agenda (3 min)

The agenda is confirmed.

20. Confirmation minutes (10 min)

The minutes of 11-03 are confirmed.

21. Updates (10 min)

The chair, vicechair, workgroups, and CSR delegate share updates.

Stefanova updates on the Humanities after Dark follow up meeting. A follow up meeting with the Allard Pierson Museum will be scheduled. Stefanova wonders whether the FSR wants to be involved again in the future. Eng shares that given the budget allocation for the event of this academic year, he prefers sponsoring smaller events that have more of an impact. Kestoros answers only if we are informed beforehand on the budget allocation. Thantry states that on a faculty level we do not have many opportunities for students to engage with each other, thus such large scale events are important to maintain. However, it is best to discuss this topic during an agenda point.

Thantry updates on the PO of 18-03 with the social safety officer. As a follow up on this, Thantry wonders whether the council wants to write an unsolicited advice regarding the insufficient communication of the faculty.

Kestoros updates on the departure of Kerzan as a council member. Mohammad will publish the vacancy for a new council assistant on the website. The application committee will consist of Artemyeva, Kestoros, Molin and Stefanova. The vacancy will be furthermore shared on the socials.

Kestoros addresses the workgroup attendance.

A meeting will be scheduled regarding the relocation of the council's office. Heijnis, Mohammad, Thantry and Tip will attend the meeting.

22. Discussing - G1000 and future steps (10 minutes) (attachment: 0)

The FSR discusses future steps on G1000, and personal organisation.

Heijnis elaborates on the agenda point. Heijnis asks whether the council wants to proceed with this project, and if yes, what that could potentially look like. The council brainstorms ideas. Mohammad reiterates Heijnis' suggestion during the last plenary. The council discusses recruitment of students to enhance student participation. Heijnis states that the formulation of the discussed question will determine the turn-out. Kestoros shares that the advertisement aspect also holds great influence. Molin suggests to give credits (ECTS) to attending students. The council decides to continue this brainstorm session during Kestoros' workgroup.
