The council has not yet agreed on a clothing-related charity initiative. Ideas discussed included collecting clothing during office hours, a potential clothing swap (though possibly too much effort), and identifying a suitable charity (Dutch member will do this?). Alternatives such as a bake sale or making Christmas cards for the elderly were considered, and the people will provide the information on Signal. A charity run was discussed as a possible future collaboration with other study councils, likely for next year. Carla will send a When2Meet to finalize decisions.

No proposals were submitted for the PR budget; this will be moved to next week.

The "fridge man" expressed frustration about delayed communication. Dani met with the secretary of the dean and may be able to follow up on the fridge issue → Dani will update us if she can take care of it. Possible purchases were



discussed: one or three desktops, a whiteboard or pinboard, a couch, and an air fryer (depending on fridge expenses). The council should soon receive new email accounts, possibly including one for the delegate.

Carla sent a when2meet, the 3rd is the better option... maybe everyone can make it happen?

4. **0&0** Update

a. AI regulation

Noor sought clarification on the Teams documents, noting that there is an implementation plan but confusion across faculties regarding the university's stance. Mireille added comments recently. Fabian noted that little progress seems to be happening and the plans are not finalized.

b. Reels

A collaboration between 0&O and PR on TER rights was proposed—creating a reel explaining the council's submissions and what they mean for students. Hollando and Dani may lead this?; a When2Meet will be sent.

5. O&F Update

a. Collaboration with Nieuwe Mensa

Johannes and Anastacia attended a meeting with the Green Office and Nieuwe Mensa about reducing food waste in the canteen. Strict supplier regulations limit food redistribution. Another idea discussed was installing a public fridge at UvA, similar to a successful initiative in Maastricht, although visibility was previously an issue.

O&F will wait for updates, as backing out of the contract is maybe not possible?

Vince added that upcoming catering regulations may give Nieuwe Mensa more flexibility.

6. PR Update

- Marleen emailed about creating a video on visiting study advisors. A recording day is planned for the end of the month. Carla noted that the OER-related filming can be handled internally, and a When2Meet will be sent.
- Knappekoppen Vrijwillig invited the council to an event on 30 November (€13.50 pp). Dani raised concerns about transparency regarding where the charity money goes.
- A meeting will all study association will be held next week to set the Borrel date

7. Delegates

a. CSR

- Completed research on the model OER; workgroups are being formed to push for changes.
- CSR advised wanting greater influence over the framework for external collaboration.
- COBO was successful.
- In the 68th GOV, the budget showed expected losses, but this is attributed to conservative budgeting and declining student numbers.

- Funding-cut strike scheduled for 9 December.
- The council voted on supporting the strike on Instagram: 11 in favor, 0 against, 1 abstention (Wytze).
- Dani will send event details and a draft social media text to vote on.

GOV will take place in 1.5 weeks; the pre-meeting is next Monday. Topics include AI regulation and OER changes affecting the private law master thesis. Concerns were raised about inadequate organization within this master and disregard for student rights. Carla requested a summary of key points on this; Livni will prepare this as soon as possible.
