4. Update from the treasurer on the budget (Mihnea)

Mihnea: The main conclusions are that tuition fees will increase and there is a €7 million budget gap. Budget cuts are necessary to close this gap while avoiding reductions in educational quality. There are more students within the Law Faculty, this is a positive trend since the government subsidized universities based on the number of graduates. At the same time, more students means also that money needs to be spend on facilitating education. Thereby, the FSR will also quite likely get the same budget as last year.

5. Update from CSR delegate (Roza)

Presented by Robin: The vote of no confidence has been lifted, and the CSR is preparing a press statement. Additionally, the CSR is debating whether meat products should be reimbursable through its budget. The CSR is reviewing key considerations for the 2025 draft budget discussion at the upcoming GOV. They have also received Bora Fidan's report on strengthening *medezeggenschap* (participation) and are discussing its recommendations. Finally, the CSR supports the long-study fine protest, with a national demonstration scheduled in Utrecht on November 14. See the action list for further details.

8. Introduction Sunmoon

Sunmoon: Had class in last block during our meetings. Has 7,6 hours paid per week and wants to join every 2-3- weeks. The FSR can always approach Sunmoon since he represents student interests within the board. Zofia: what do you do?

Sunmoon: As a student member of the board, I join board meetings every week. I have an advisory role on the board related to everything connected to education and students. Also, I am responsible for all the study associations (legal study associations that are recognized by the faculty). It's important that I have a connection with study associations and the FSR to represent student interests within the faculty.

Len: is there anything that we should know?

Sunmoon: Due to new government policy, it will be examined if PPLE will remain the right to teach in English.

Mihnea: we talked about it in the OV.

9. Reflection on the OV

Mihnea: I expected more peoples to show up from the board.

Jose Augustijn-Brugman and Yvonne Donders were not present.

Sunmoon: if Jose is not working on the budget, Jaap is responsible. Jaap is the controller and accountant of the faculty.

10. FDR Budget:

Myrthe van Amstel sent a budget on 1^{st} of November asking for our advice, the deadline is the 13^{th} of November.

Len: Before this budget, we already gave our advice on the draft budget.

Sunmoon: when did you receive the draft and how is it different from the final version?

Len: On the 9th of October we got the "conceptbegroting" forwarded from Mirthe.

Mihnea: Jaap Baker said that the differences are not too big. However, the gap in the budget is closer to 7 million then 6 million euro. There won't be many changes for the next year, the year after that will be different.

Len: Are there rules on how much time get have to decide?

Sunmoon: it should be in the faculty regulations.

Robin: This is something that we need to discuss and we need to vote.

Len: Maybe they meant the 13th of December?

Sunmoon: The deadline should be around the pre-meeting of the GOV. Because the Faculty budget will be a topic in the GOV. Maybe you could propose to put the deadline on the 27^{th} of November.

→ Zofia will suggest moving the deadline.

Len: Sunmoon, you did budget last year, on what topics do we have consenting rights?

Sunmoon: On the first money streams we have consenting rights. On the second and third money streams, we have advisory rights.

Len: where can we find this information?

Sunmoon: I learned this during the workshops. The CSR requested legal advice on their consenting and advising rights, you could ask them for this information.

Len: O&F could look into this. In case we don't get an extension on the deadline, we should prepare an advice.

Sunmoon: they usually cannot set such a hard deadline.

Johannes: I will work on it.

Friso: with OER deadline coming up we should try to postpone it.

Zofia: we should focus on the OER proposal deadline and then work on the budget.

11. Update from the PR Committee (Robin)

Robin:
