#### 7. CSR delegate update (Roza)

[30.01.2025 email] from FSR FMG answer, vote, stance

Zofia: do we send them our stance on the house rule things?

Johannes: would support the CSR but maybe wait until there is final advise.

Mihnea: there seems to be a discrepancy between international law and the house rules but not sure if there is much to do at the moment.

Livni: would be good if they address it with the CvB. Do not agree with everything but also should let them negotiate it. CSR can do it on their level.

Len: This topic is suitable for the CSR we should not interfere in their field and might come across otherwise as we do not trust their judgement.

Zofia: conclusion is that we probably need to wait until the CSR has a solution and then we can vote on it.

Livni: because it is a legal procedure, us as law FSR also need to make some research.

Zofia: will send an email saying that we will not interfere at the moment.

## 8. 0&0 committee update (Fabian)

Recap of Q&As

Fabian: we had the OER Q&A. It went alright but we did not push more than we already addressed. Only the phrasing about the re-evaluation of an exam we contested. They formulated it vague so we asked them re-formulate it in a more clear way. There was also a big discussion about another article regarding student services and BSA.

Zofia: Also TER Q&A session. Some of the things they rejected were because it was not for the TER but maybe address it on the website or with the study advisors. Also got far with the accommodations discussion.

Len: Mid-term evaluation time changed now to 18 days. Also they now need to give example answers.

Fabian: reached out to Dan regarding AI rules and also suggested a meeting if required. Also reached out to Yousra if she needs support on the AI file. Also progress with the questionnaire for the ALF file but will discuss that later.

Zofia: reel is coming out on Monday.

Len: scheduling a meeting with the other PR chairs to work on an election plan. More about that next week.

#### 10. GOV prep

Zofia: from our side mainly anonymous grading (sent by Len) and ALF (taken care of by Fabian and Livni).

Fabian: students report very high pressure in ALF. 44 % of students spent 8-10 hours a week. It is not for credits but you need to pass it to take the exam for the course.

Zofia: why is there no credits for it?

Len: we should also bring that up.



Fabian: It is argued that ALF is to give students real life experience. If ALF is still mandatory it would mean that total hours spent on that course is maybe about 30 hours a week.

Len: if ALF is tied to the course the working hours of the course should be reduced in a way that it works out time wise for the ECTs.

Fabian: main point from the questionnaire: there are too many deadlines and too much workload. Also to improve the writing there needs to be time to reflect on it which is currently barely possible.

Len: do people have points for anonymous grading? - talked about technicalities

Livni: there is again a problem with professors not uploading material and practice questions in time.

Johannes: maybe a reminder could be sent via canvas.

Mihnea: maybe before every block this could be done:

Livni: maybe the student assistants could check it.

Mihnea: are there any updates regarding the PPLE re-accreditation?

Zofia: we can ask for an update.

Zofia: Mirtha van Amstel will leave after this GOV but we will only know who will follow her in the future. Maybe we can reach out to Candida to come up with something nice.
