#### 5. O&F Committee Update (Johannes)

Johannes: The career event is the busiest file now. Mihnea, Friso and Livni attended the meeting. It will be on the 7<sup>th</sup> of April at 13:00. This week, there was no engagement table, the table was not reserved so we should plan this better ahead. The first mental health reel was sent to mood lift, they will give us their input. Hopefully, I'll be able to share it with you during the next PV. We are implementing the findings from the evaluation weekend and are also making an oversight for the next council. We also have an election file right now.

#### 6. Budget decision from O&F (Johannes/Mihnea)

Mihnea: Our total budget is 12K. Right now, we have 8.5K left. The cost of the evaluation weekend was around 2500 euros. We also spend 300 euros on the Valentine's Day CoBo and 300 euros on our own CoBo. We must account for the transition weekend and the career event. The photographer of the career event will cost around 300 euro. However, if we don't get subsidized, we will need another 200 euro for potential catering. Making the total costs of the career event 500 euro.

Livni: For the transition weekend, we allocated 200 euro per person, amounting to 5200. And there should be money left for a social bonding event.

Mihnea: So, we would have 3k left.

Johannes: We can put more money into the career event, and we can look at the budget and see what we used and what not. We could get hoodies, which would fall into the costs for elections.

Mihnea: Would people agree on spending money on hoodies for the elections?
