7. CSR delegate update (Roza)

Draft of ethical collaborations? [Assessment guidelines...] file

Roza: You can see a table on the third page. The EU common military list will need to be checked. It's also about cyber attacks, spying and privacy, climate and sustainability. The EU-index doesn't always seem to indicate the real circumstances in a country and can be seen as political. Academic freedom is an important part of the table.

Len: I think the document is overall good. However, on pages 6 and 7, the section on risk assessment stands out to me. The distinction between the risk categories feels unclear, as the actions taken across different categories seem to be the same.

Roza: Can you send this in an email?

Zofia: I think that a controversial partner should always be on high risk? I will also send this as an email.

Livni: Are they asking students for their advice? Maybe we can find a way to give the opinion of students more weight. Roza: I started working on the file of academic freedom. In 2023, the report "krachtig en kwetsbaar" came out. They came with recommendations on academic freedom to the university.

Roza: We are starting to publish our work more as the CSR. The house rules will be discussed and we are deciding on this. And there is an ethics committee. Concerning the elections: I had a meeting with the communications office of the UvA, they are enthusiastic about sending a personal letter from the dean to every student. Last week we discussed the timeframe of the elections, the FSR had some concerns about this. FNWI has sent a letter expressing their concerns. The CSR wants to make a final decision and wants to get more input from the FSR's. It will probably be 6/7 working days of elections.

Livni: Will the campaign budget also be expanded if the campaign period is longer?

Roza: probably not.

Robin: Maybe we need to give extra money to smaller faculty parties. Parties that only have one faculty might need extra support.

Livni: This extended election period will benefit the bigger parties.

Roza: We could look into a fair way of dividing the budget.

Zofia: What if we invite the heads of the smaller parties to talk about their budget and options?

Roza: I want to organize a brainstorm session with all the PR committees of all the parties.

8. 0&0 committee update (Fabian)

Len: We had a meeting with Ingrid Pancras, the examination expert at the law Faculty. We talked about anonymous grading and the use of AI. She was not aware of the fact that in PPLE we are required to put our name on tests. She is from the TLC, they are more concerned with the law bachelor.

Robin: we posted about the AI working task. We were at the engagement table again. And now we are focusing on the campaign.

Roza: I posted the first Tiktok. I have some other drafts to post next week. It's called studentenraad.fdr.

Len: I went through the file last week. I separated topics that students brought up into different categories. People are not so satisfied with the way that education is being assessed. People would like less group work, more individual papers and less exams. Ingrid Pancras said that you learn the best when you are continuously assessed throughout the block instead of having one exam at the end of the block. Someone said that the canvas page on thesis is chaotic. There were complaints about the elevators, maybe we can look into making a change. Concerning teachers, some students would like them to respond quicker and to hold themselves to deadlines.
