#### c. Studieverenigingenoverleg

Chloë has emailed Daan to say this:

Ik zal nog een FOJS faciliteren in de week 50 (12 december-16 december). Ik zal degene die ik in de maillijst heb mailen met de vraag of ze een lijstje willen maken zodat het voor u misschien ook meer helderheid schept over de vraag hoe groot elke vereniging is. Ik zal vragen of de studieverenigingen het lijstje z.s.m. naar u op sturen zodat u er een reactie op kan geven bij het volgende overleg. Verder zal de FSR geen verdere stappen ondernemen om een bestuur op te zetten, of verantwoordelijkheid op zich nemen met betrekking tot het informeren van studieverenigingen etc. Misschien is het een idee om zelf de studieverenigingen te benaderen daarvoor? Wij hebben als FSR geen mandaat om kamers toe te wijzen aan studieverenigingen, wij zijn ook geen studievereniging. Het enige wat we willen bewerkstelligen is meer openheid, verder heeft de FSR geen enkele verantwoordelijkheid met betrekking tot de huisvesting van de studieverenigingen en de rechtswinkeliers.

The next meeting is Tuesday 13th of december 16:30 o'clock.

Anthony explains that there might not be enough room to fit all the "rechtswinkels" and the group agreed that by next week every study association will reply with how they work and how they need to use the rooms. This information will then be send to Daan.

# d. Ongevraagd advies over voorlichting

Maurits explains that the UvA Rechten website is part of the general framework of websites of the UvA. He thinks it would be much easier if every faculty can build up its own website and design, based on its own wishes (like Columbia Law School:

http://web.law.columbia.edu/). This, however, is more of a central issue. Maurits recommends the direct translation of OER and Policy changes to the A to Z list, and on a page that would be dedicated to the newest changes to policy (in addition to Mededelingen, News, etc. (or as part of these categories)).

The council agrees with this proposition and Maurits will write a draft advice. Anthony adds that one of the "voorinvesteringen" subjects was to create "wegwijzers" and he thinks Maurits should link this in his advice.

## e. PPLE

Marlene and Sasha are waiting for an update on the "Voorinvesteringen" from Radboud. They may potentially write an "ongevraagd advies" on the Masters procedure.
