- 51 There is no clarity about the date yet.
- 52 **7. Dossierhouders Update**
- 53 OC: Anne Myra did not have any more responses.
- 54 Refugee: Marlene is looking into why students are being rejected and will have a
- 55 meeting with Tesseltje.
- 56 **8. Advice werkgroeponderwijs**
- 57 Maurits wants to know who is in favour of discussing this advice: 7 people. Anne
- 58 Myra thinks the council does not agree on the subject of this advice, so she's
- 59 doubting to discuss this. It concerns Marlene to send this advice, because the
- 60 board could take it out of the FSR's hands. Anthony is afraid that nothing will



61 happen after Blended Learning. Tjapko does not think it is necessary to discuss
62 this from a Blended Learning perspective.

64 - Chloë and Anne Myra would like to reserve more time for feedback during
65 the seminars, just like Recht & Menselijk Gedrag en Rechtsfilosofie. 6 people are in
66 favour. Anthony thinks teachers should have the freedom to arrange their own
67 course. He would also like to see it digital. Voting in favour of punishments: 2
68 people. Without punishments: 5 people. Voting in favour of bonus points: 7 people.
69 - Chloë and Anne Myra would like add extra mandatory assignments online,
70 for instance multiple choice, for students to practice more. Maciek explains this
71 will be very expensive. Marlene would not like to introduce too many mandatory
72 things at the same time. Chloë reacts that she heard a lot of students complain
73 about students not knowing the materials. Anthony does not want to make it
74 mandatory and wants to leave the monetary discussion for the OV. No one is
75 favour. 7 people are in favour if it is not mandatory.
76 - Chloë and Anne Myra would like to integrate more actualities in the
77 “werkgroepen”. In order to achieve this they want to put a part of the “werkgroep”
78 answers online. This means students can ask questions about the answers. Sona is
79 afraid students will not show up. Anne-Fleur thinks a solution could be to put all
80 the answers online in the last week. Anthony states students should not go to
81 “werkgroepen” for the answers, but for the interactive discussion. Tjapko thinks a
82 problem will be that teachers use the same questions each year. Anne Myra wants
83 different questions every year anyways. Voting on part of the answers available
84 per week and all the answers available end week 7: 8 people in favour.
85 - Chloë and Anne Myra would like to add more skills in the “werkgroep”.
86 Sasha thinks the downside might be that it does not add anything to the learning
87 experience. Anthony explains that this will happen anyway.
88 - Chloë and Anne Myra would like to make “werkgroepen” mandatory in
89 order to be able to pass a course. Chloë mentions that in Psychology points are
90 deducted. Sasha explains that in PPLE students are kicked out of the class. Anne
91 Myra thinks students should still be able to make their exams. Voting on
92 mandatory in general: 4 people in favour. Marlene thinks the random testing and
93 getting the answers in week 7 would make attendance useful. No one is in favour
94 of kicking students out of a course. Tjapko and Anne Myra think it would help if
95 students have to enrol for exams separately if they did not do attend working
96 groups actively. Marlene would like to discuss this separately from the advice.



97 - Chloë and Anne Myra would like to make it more difficult to switch
98 “werkgroepen”. Anthony thinks it is a problem that “werkgroepen” are very busy,
99 but that the flexibility is a good thing for students. Tjapko wants to stress that the
100 concept of “werkgroepen” is going to change because of Blended Learning. Anne
101 Myra stresses that the point of this advice is to organise the courses more like
102 PPLE and Honours. Chloë thinks it helps if you bond with your “werkgroep”.

105 **9. Advice Democracy**

106 Maciek wants to make three points: ‘effectief beleid’/evaluation with the FSR
107 (evaluation and the ability to terugdraai beleid), the council needs to be informed
108 better and a student member in the Examcommission. Sasha wants to know if
109 there are other faculties with student members in the Examcommission. The
110 council is in favour of this advice.

111 **10. M-OER / OER end-grades**

112 What do we think of the way of rounding up grades between 5.6 and 5.9 to 6
113 instead of preserving the real grade? Anne-Fleur explains the OC wants it to show
114 a 5,6 in SIS, instead of a 6. The M-OER leaves room for faculty freedom to choose
115 between 5,6 or 6. Faculty freedom voting: 9 people in favour.

116 **11. NSE**

117 Anthony explains that there a few main topics: informatievoorziening,
118 studiebegeleiding, betrokkenheid bij opleiding en oriëntatie op de
119 beroepspraktijk. If there subjects the council wants to discuss they should let
120 Anthony know.

121 **12. Evaluation Zichtbaarheidsactie**

122 Anthony explains the council only flyered three times because there were issues
123 with FS. Anthony wants to forget this and do two monthly actions for the rest of
124 the year. **TD 170314-06 Chloë will propose days for visibility actions and fix it**
125 **with FS.**

137 animo for this. The council wants to advise positive, if other students can also
138 enrol for certain classes.
