Tara states that the CSR discussed the alternative ways to have the student elections and the CvB will have the final word on this. Nina asks if the FSR has any say in this. Tara states that the CSR discussed some scenarios.

i. Voting on officially making Tara officially the CSR delegate

Tara states that she will be the definitive CSR delegate from the FSR-FdR. Rogier states that he is fine with Tara as a delegate but he would like to know what is going with Roos (the former CSR delegate).

Tara states that Roos will send the council a written statement with her stepping down as a delegate. She also states that she has a lot of contact with Roos. Tara states that next week the voting will happen.

Samir asks if there are any more updates. Tara states that the CSR will have a meeting with the CvB.

Yoav asks what the stance of the CSR is on period 6. Tara states that the UvA stance is that the students should be back on campus in period 6. Samir states that there are some privacy issues with using Zoom during lectures. Tara states that she will bring this up with CSR and discuss the privacy issues. Nina

asks Tara if the CSR has weekly meetings with the CvB. Tara states that the chair of CSR has meetings with some central board members. She also states that the CSR discussed the payment of the tuition

fees. Tara states that the CSR-FSR dinner is also postponed. Samir asks if the CvB has any plans on worst-case or best-case scenarios. He states that students deserve to have more information. Tara states that the CvB is working on all sort of scenarios but they will not share it with students. Tara will ask if they could share this with the student councils. Yoav states that UvA should be flexible in period 6 for students. Nina states that she agrees with Samir and she would like to have more information from the CvB. Samir states that the UvA should be more clear on the information for the further future.

c. O&O

i. OERs

Tara states that the responsibility should be better with the task sharing. Rogier states he was not doing anything with the OERs and he apologizes. Tara states the finalized advises were sent to everyone and she asks the council to check the documents. Nina states that she is happy that some comments were implemented in the concept-OERs. She also states that the rounding-up topic is still very important. This is the same for the taaltoets. Rogier states that he had a meeting with Nollkaemper about the taaltoets.

d. Questions to the Dean

i. Mental health – anything concrete we would like for them to do?

Rogier states that he is happy with the questions on the Instagram of the FSR-FdR. He also states that some students have serious issues during this crisis and he would like to address this to the Dean. Nina states that she already has one email received from a student with her personal problems. She states that teachers could be more humane to students in their communication. Tara states that the next two OV meetings are cancelled. She also states that the way of meeting with each other will be discussed with the faculty board. Yoav asks what the status is on the photo competition. Tara states that this will happen when the building is open again. Rogier suggests if the faculty dean could make a video message to the students. Aashish asks if the voting will happen on the photo competition. Tara states that this was already done in a previous PV.
