1. Opening of the meeting

Domenico opens the meeting at 17.03

2. Setting the agenda:

a. Strategisch overleg

Domenic states that he and Jane attended the SO. He states that two points were discussed which was important to the council. First, the topic of online education was discussed. He states that lectures might be changed into so-called 'kennisclips'. Secondly, the research budget was discussed. He states that there is going to be less money for teaching. He also states that he will send the relevant documents to the council. He asks what the stance is of the FSR on lectures. Thomas states that the lectures are not recorded right now. Clemens asks if there will be fewer lectures. Domenico states that this is correct. Robert asks if the lectures will be replaced by online clips. Jane states that this is correct and the lectures will be replaced by online clips in the future. Rogier asks if there is a document that states this. Domenico states that it is not on paper and the council should ask for clarification. Rogier states that education should be on campus and he would like to have a confirmation of this discussion. Jane states that online clips should be something temporarily. Thomas asks why this is happening. Domenico states that he is not sure why. He states that he will look into this. He also asks if the O&F can look into the research budget. Jane and Domenico explain the topic of English courses in Dutch bachelors to the council, as discussed in the SO.

b. Social distancing campaign

Domenico asks if the PR committee has an update on the social distancing campaign. Alla states that currently, the introductions are happening on social media. She states that after this the campaign will start.

c. Law associations meeting

Rogier states that he had a meeting with the law study associations. He states that the associations asked when meetings on locations could happen. He also states that he can be reached when they have tips or questions. He also states that the topic of events on location was discussed. He also states that they asked if the associations' room could be used as well. Rogier and Domenico discuss the topic of books selling through the associations. Rogier states that the associations would like to know what their board year will be this study year. He also states that he would like to be in contact with the PPLE associations AIM. Katie states this was discussed within Inter and a meeting will be scheduled soon. She states that she will arrange this with Rogier.

d. Office supply expenses

Olaf states that only one expense cost was sent to him. He states that the list will follow later.

e. ASVA call

Domenico states that he had a meeting with board members from ASVA. He states that ASVA will bring out a report on social safety. He states that ASVA asked what the FSR's stance is on social safety.

3. Other updates

Domenico states that the central board supports the idea of having more lectures on location. Rogier states that he is also in favour of this idea and he would like to bring this up with the faculty board and works council.

4. WTTK

GOV points

The secretary states that the agenda meeting for the GOV is on Monday. Domenico asks if the council has any points for the coming GOV meeting. Katie states that the topic of education on location should be discussed. Domenico states that the letter of advice on testing/exams should be discussed. Rogier states that the council should discuss what the plan is of the faculty board. He also states that this might help with the communication with students and the council will help with this. Alla states that the topic of in-person education is important. She also states that it should be made clear what is going to happen on the university the coming time. Rogier states that the numbers are indeed higher, but there is more testing as well right now. He also states that with new measurements this will affect the education on location. Robert states that the issue of the budget can be discussed as well. Rogier states that the topic of backtracking is something important as well.

Katie states that the council is offered training from TAQT. She states that she will send a link to the council about the different trainings. She asks what everyone would like to have. She explains the different kind of training to the council. She also states that those trainings are important to everyone.

Alla states that a news article from the FSR will be released on the UvA website.

Robert states that PPLE students send an email about the GPA. He states that there is a change between electives and minors. He asks if this is normal. Clemens states that he knows about the change and the decision was made two years ago. He also states that this can be discussed with Radboud Winkels. Rogier states this topic will also be discussed within the O&O committee.
