1. Opening of the meeting

Domenico opens the meeting at 17.04.

2. Setting the agenda:

a. OV

Domenico reflects on the last OV. He also states that it is better for the next time to have an overview of all the points that will be discussed during those meetings. Assamaul states that in the CSR they have OV-prep meetings. He also states that this might be a good idea for the FSR. Domenico states that the council can look into this.

b. CSR update

Assamaul states that he discussed two big topics. He also states that the CSR signed a letter regarding the stress students experience during the current situation. He also states that the model OER was discussed. Alla asks if there was anything relevant to the council discussed. Assamaul states there were some amendments discussed that can be relevant. He also states that he will send this to Alla. Thomas asks if anything regarding mental health was discussed. Assamaul states that he does not know. He also states that the secretary of the CSR should send meeting pieces to the FSR. Rogier states that documents from the CSR might be confidential. Assamaul states that this only happened once or twice this year. Domenico states that it is better if the FSR has more information. Alla states in reaction to Rogier that it is up to Assamaul as he is the CSR-delegate. Domenico states that the attachments should be sent to the FSR.

He also states that top lunches are basically in Dutch and it would be better to separate the events. Jane states that it might be better to focus more on just the student council instead of just the student elections. Vincent states that inviting English speaking guests can be a solution. Thomas states that he will pick this up.

Thomas explains the design on the sleeve. Katie states that she would like to vote on the design. Everyone is in favour of the design.
